Mr. Fraser:

We are attorneys for Pre-Paid Legal Services dba LegalShield ("LegalShield"). We write on behalf of LegalShield to demand that you immediately cease and desist your misuse of LegalShield's trade secrets, that you remove all LegalShield trade secrets that you have posted on-line, or elsewhere, from public view, and that you return all LegalShield trade secrets in your possession to us. We also demand that you cease and desist all solicitation of LegalShield associates and your on-going defamation of LegalShield.

You have a blog at www.empowernetwork.com/byd/blog/legalshield-termination-and-our-journey-back-to-making-money-and-real-residual-income-faster-than-before/ which includes a picture of an organizational report listing names of LegalShield associates, as well as images of other LegalShield reports. This is trade secret information of LegalShield which you are prohibited from disclosing pursuant to paragraph 8 of the Associate Agreement you entered into with LegalShield, and pursuant to Oklahoma law. Though that Agreement has been terminated, the obligation not to disclose LegalShield's trade secrets survives the termination of the contract. This misuse of LegalShield's trade secrets is also prohibited by Oklahoma Law, 78 Okla. Stat. § 85, et seq. The blog, as well as other social media postings, are also defamatory and constitute a solicitation of LegalShield associates.

Therefore, we demand on behalf of LegalShield that you immediately cease and desist all use of LegalShield's trade secrets, that you specifically remove from your above identified blog, and any other location, the organizational report as well as all other reports of LegalShield or listing LegalShield associates of any kind, that you remove all defamation of LegalShield and that you return all trade secret information of LegalShield in your possession to our office. We also request that you preserve all electronic evidence in your possession, including computers,
